

# RIVERSIDE COUNTY BEHAVIORAL HEALTH COMMISSION

MEETING MINUTES FOR September 3, 2025 • 12:00 pm to 2:00 pm

#### CALL TO ORDER, PLEDGE OF ALLEGIANCE, ROLL CALL AND INTRODUCTIONS -

Madam Chair Brenda Scott called the Behavioral Health Commission (BHC) meeting to order at 12:00 pm and led the pledge of allegiance. Commissioner attendance was taken by roll call and followed by introductions.

#### MINUTES OF THE PREVIOUS MEETING -

Victoria St. Johns made a motion to approve minutes as written from July 2, 2025 and April Smith seconded the motion, and all were in favor.

**CHAIRPERSON'S REMARKS** – Madam Chair Brenda Scott thanked BHC liaison for organizing the annual training that took place in August.

#### **COMMISSION MEMBER REMARKS -**

#### PUBLIC REMARKS -

Joseph Page gave praise to the department and was confident he could depend on the department as partners to support the community. Also recognized the department for the media program they've provided to the consumers to allow them a platform to share their stories and testimonials.

Cat Ferguson with the non-profit ILP (Independent Living Partnership) announced that the program provides transportation for those who cannot drive and asks that this information be shared with those in need of their services so they can reach out.

Antonio V. gave recognition to the Blaine Clinic, sharing he attends groups there and they have helped him to express himself, speak and connect with others. He shared that consumers and himself could benefit from a literacy group to help the group articulate and express themselves and would like more attention brought to his suggestion.

Another public member shared her son is a consumer of behavioral health services with the department and one of her concerns was that her son's visit to the clinics cannot be documented into epic and the challenges she has faced with billing.

# DIRECTOR'S REPORT - Dr. Matthew Chang

Dr. Chang provided a brief update on department staffing, sharing that the county is on a tight budget, but RUHS BH is currently able to hire for some positions and the DA's office is also able to hire but other departments are on a hiring freeze. He concluded by sharing that although there may be positions posted they cannot all be filled without proper justification and proof that productivity is being met.

#### **CELEBRATE RECOVERY**- Consumer Peer Services (Kristen Duffy)

Kristen Duffy, Consumer Peer Services Program Manager, introduced Sergio Rodriguez. Mr. Rodriguez shared his experience through the system of care and how losing his brother a few years ago has affected him. He expressed that the crisis team had assessed his brother, and he carries guilt over his brothers passing especially because his brother was in a convalescent home and when he returned home with him his brother was never the same. Mr. Rodriguez shared that his brother's passing has affected him deeply and that his brother helped him a lot and through his loss he has turned to the department for help and through services he received at Pathways to Success he is now an interpreter. He concluded by sharing he wants others to know if you give the system an opportunity to help it can work for you too.

Greg Damewood made a motion to approve the BHC Annual Report as written to send to the Board of Supervisors for review and approval.
