Richard Divine asked if there were any additions, corrections, or deletions to the board minutes of the November 12, 2024 meeting. There were no additions, corrections or deletions that needed to be made. Bruce Sherr made a motion to accept the corrected minutes and Huynh Cue Nguyen seconded the motion and it passed 10-0.

NEW BUSINESS:

Adopted Family Gift Giveaway and Snowflakes Recap:

Shawn Harris gave an update on this matter and said the family was extremely grateful for the gifts and monies that were donated by the board members and others. She added they had 497 Snowflake requests, and they were able to fill all 497 requests.

Interactive Review of Desert Board Goals/Status/Representation:

Dr. Janice Quinn gave a recap of past Desert Board's projects including police training, working with desert employers to hire our clients, the mental health lapel pin, the anti-stigma push, school programs, and the art show. She asked for suggestions for new projects or tasks that the board may want to tackle this year. Tori St Johns suggested we try to do something to ease the burdens on immigrants' legal rights and procedures given the current change in immigration practices by the Trump administration.

Dr. Janice Quinn asked if we needed to add another committee that might need to be added to our Board's agenda or changes to the Board assignments on the existing committees. There were no suggestions for new committees to be added and Eva Guenther-James said she would be willing to take over the Criminal Justice Committee from Carole Schaudt.

Substance Abuse Program Update:

Gabe Kason said the Harm Reduction Program is still ongoing and a lot of supervisors will be going to conferences next month. He said they are giving out gift certificates to participants every time they test negative for a stimulant. There are two clinics participating in the program and more will be coming onboard this year. He said they are starting to clear out the Monroe building on the substance abuse side so they can move into their new location. They are also now collaborating with detention facilities in Riverside County every Wednesday morning to offer services to inmates confined there. He concluded by saying they will have a drug court graduation on January 23, 2025 and

ADULT SERVICES ADMINISTRATORS COMMENTS:

Rachel reported they are partnering with the Riverside Sheriff's Corrections Department to work with inmates being released to ease their transition back into the communities they live in. She added the Banning Children's Clinic is now fully staffed. She said they recently started training staff in Family Therapy Training. She said they are continuing to send staff to Harmony Haven in Banning to assist the youth there with behavioral health issues. She also reported that the TAY Desert Flow Center recently got their local in-person psychiatrist back.

Rachel said there will be a rapid improvement event in Blythe on January 21 and 23. The topic will be community partnerships. There will also be a Blythe Collaborative meeting on January 30, 2025, from 11:00 AM to 12:00 PM. Rachel said they are still struggling to recruit for open positions at the Blythe clinic, but they were successful in hiring a full-time clinical therapist for Blythe. She said they started a new Mom's Program in Blythe also as well as an ongoing expansion program at the clinic. She added that Carina Alcala is the new supervisor for Indio Adult Outpatient and has been with the department for about ten years. She also shared the position openings for the Banning and Indio clinics and Windy Springs.
