CALL TO ORDER, WELCOME AND SELF INTRODUCTIONS:

Dr Janice Quinn called the meeting of the Riverside County Desert Behavioral Health Advisory Board to order at 12:08 PM. Self-introductions of all who were in attendance in person or by teleconference followed.

CORRESPONDENCE AND ANNOUNCEMENTS:

Christine Thomstad mentioned the NAMI Walk will take place on November 15, 2025 at the Palm Desert Civic Park. She also announced that NAMI Coachella Valley will be starting a Spanish Family Support Group which will be held on the second Monday of each month at Oasis Community Services on Dr. Carreon in Indio and she will provide a flyer on it later.

Shawn Harris announced that they will be hold a "Fall Festival for Children" at the Myers location in Riverside on October 23, 2025 which will feature children's art.

ACCEPTANCE OF MINUTES:

Dr. Quinn asked if there were any additions, corrections, or deletions to the board minutes of the July 8, 2025 meeting. There were no additions, corrections or deletions that needed to be made. Huynh Cue Nguyen made a motion to accept the minutes, Joe Butts seconded the motion, and it passed by a unanimous vote. NEW BUSINESS:

Desert Wraparound Program:

Michael Bohon-Lara gave a presentation utilizing some PowerPoint slides about the program. He said they encompass the entire desert area from Banning/Beaumont to Blythe and are a strengths-based family program which is predominately probation focused in that most of their referrals come from County Probation. He said there are three teams consisting of five behavioral health staff, one public health nurse and one probation officer for each family.

Window Walk Gallery at the River Update:

Dr. Janice Quinn said the Gallery is once again up and running at the River and encouraged everyone to take a trip there and see the art displayed there. She said all the Gallery art is in the units between Dave & Busters and the Cheesecake Factory.

OLD BUSINESS:

Report on Department and Supervisors Review of May 2025 Behavioral Art Festival at the Taj Mahal:

Dr. Janice Quinn said this meeting was held just before the September Board meeting and a lot of good input was received. She said the biggest issue that arose was that some artists submitted more than the set limit of five pieces of art. She said starting next year there will be a strict limitation of five pieces of art per artist in each category. Artists are able to submit art in multiple categories, but each category will be subject to the five-piece limit.

CHILDRENS SERVICES MANAGER COMMENTS:

Rachel Gileno covered this for Kelly Grotsky. Rachel said TAY Desert Flow was awarded a \$453,433 2-year grant to provide Housing Navigation Services and Support for youth ages 18-24 who are experiencing homelessness. She said any youth between 18-24, who meets the definition for homelessness, can qualify. She added that priority will be given to youth in the Coachella Valley and the goal is to serve 80 youth per year. Youth do not have to be linked to Behavioral Health services or a Behavioral Health program. Rachel said they are in the process of hiring a housing navigator. She said this will be a Peer Support Specialist position and the ideal candidate will have lived experience of previous challenges with housing/homelessness.

Rachel said as part of the Behavioral Health Services Act and BH Connect, Children's Services will have to add two new Evidence Based Practices to Riverside County. The two new ones will be "Multisystemic Therapy" (MST) and "Functional Family Therapy" (FFT). Rachel said Kelly has been leading an implementation workgroup and will be releasing an application soon for providers to apply to be MST and FFT providers. More information on all this will be forthcoming and per DHCS, all counties must implement these new EBT's by July 1, 2026. Other children's EBTs include High Fidelity Wraparound and PCIT, both of which Riverside County already offers.

Rachel said Kelly hired a Youth ECM supervisor, Brian DeOliveria, who was previously the Senior CT at the Banning Clinic. She added while Youth ECM is still in the planning stages, Brian is supporting the Banning Clinic while Sean finds a replacement Senior CT. She said Brian has been participating in Rapid Improvement Events (RIE) related to Youth ECM. Rachel said Brian and Kelly completed a Youth ECM Roles and Responsibilities 3-day RIE and Brian will be participating in a Youth ECM Access Team RIE at the end of September. She added the hope is that Youth ECM will be available in October 2025 pending a contract execution.

Finally, Rachel said Rosie's Desert YHIP team has relocated from the Monroe Building to the Indio Children's Clinic, resulting in both programs being housed together. YHIP has now been rebuilt and is now fully staffed pending a new CT who is in the onboarding process. Youth Hospital Intervention Program (YHIP) is a Full-Service Partnership (FSP) that supports youth that have been psychiatrically hospitalized and offers intensive services in the home and field.
