



# The Future of Riverside County Health Coalition: Continuing the Steps Towards Action

The second quarter meeting of the Riverside County Health Coalition (RCHC) was held on April 17, 2024. There were 40 participants in-person and 53 online.

A total of 11 individuals completed the feedback survey for an 11.8% response rate. The following analysis examines their responses to the survey items.


#### **Attendance Type**

In-Person: 6





#### Satisfaction with **Individual Components**

### **Applicability of Content and Knowledge Gained**






### **Community Health Assessment: Future Topics of Interest**

The following are topics that respondents would like to see on the Community Health Assessment (CHA) that were not included in the current version:

- One respondent mentioned that if housing is going to be a priority area, then data is needed to support it such as point-in-time counts, affordable housing inventory, etc. They would like to know more about the barriers to affordable housing as well as barriers to mental
- Another person would like to hear about initiatives and ways to get involved.
- Bullying in schools
- Homelessness
- Smoking
- Interdisciplinary connections between health and the environment
- Climate change





## The Perception of Top 5 RCHC **Priority Areas**


Top 5 Priority Areas:

- Housing
- Mental Health/Suicide Prevention
- Health Disparities/Health Equity and Justice
- Underserved Populations
- Systemic Racism

Seven respondents agree with the Top 5 areas of focus while three individuals do not.

Those who expressed disagreement provided the following feedback:

- 1) Housing and 2) Mental Health/Suicide Prevention are subject matter areas while 3) Health Disparities/ Health Equity and Justice, 4) Underserved Populations, and 5) Systemic Racism are lenses we could use to look at those topics as well as others. Therefore, #'s 3, 4, and 5 should be embedded in every subject. Whereas, #'s 1 and 2 are two initial subjects.
- #'s 4 & 5 are overarching and unmeasurable.
- Climate Change should be added.

### **Networking:**

More time to hear what others are doing and how to collaborate together.

More focus on partnerships, initiatives, and grants.



## **Community:**

More updates from the community to show that they are being heard. Conduct outreach to community members to bolster involvement in initiatives.



### **Demographics:**

Latino-based health equity initiatives.

Autism in adults and knowing what resources are available.

- Conduct effective outreach. Ensure fliers are being distributed and that there is community knowledge about joining the RCHC.
- Two individuals provided a lengthy list of organizations to include in the RCHC.



### Feedback is positive overall.



- Survey response rates tend to be very low, and it would be much more beneficial to have a more representative sample of both virtual and inperson participants.
- The survey should be advertised more markedly, and periodic email reminders should be sent.
